This will cover material defects resulting in failure of the fastener screws for residential and commercial applications and warrants against rust and corrosion for the life of the project. Limited Warranty does not cover chipped paint on the head of fastener screws during installation nor does it cover paint removed by sanding of wood surfaces. THIS LIMITED WARRANTY IS ISSUED IN LIEU OF EVERY OTHER EXPRESSED AND ALSO IMPLIED WARRANTIES, COUNTING THE WARRANTY OF FITNESS, AS WELL AS EXPRESSLY OMITS LIABILITY FOR ANY CONSEQUENTIAL DAMAGES.
